Short listed candidates will be invited for a formal Skype interview shortly after the AFA to determine the list of candidates for campus visits at the University of Sydney Business School, Sydney, Australia in January/February 2017. Final decisions will be made shortly after campus visits.
- For those candidates who are not attending the FMA or AFA conferences, they will be considered in line with the above timeframes depending on when they submit their application.
