The Financial Stability Department at The Riksbank, Stockholm invites applications for an Economist in the Financial Analysis Division.

JOB DESCRIPTION: As an Economist at the Financial Analysis Division, you will be analysing risks and vulnerabilities in the financial markets that may affect Swedish financial stability. You will also analyse the structure of the market and non-banking financial institutions/participants, including insurance companies and investment funds. Your work is an important part of the Riksbank's stability assessment, which is published in the Financial Stability Report twice a year. You will mix long-term analysis with short-term tasks and contribute to the policy work at the department within your area of expertise.

JOB QUALIFICATIONS: We are seeking applicants with good knowledge and a keen interest in financial market analysis, preferably focusing on the functioning of the markets and the build-up of risks and vulnerabilities. You have a master's degree in economics, financial economics or equivalent with a technical orientation (Master of Science). The full or partial completion of a third-cycle (doctoral) programme within a relevant area is an asset. If you have not done doctoral studies, you have instead at least 3 years' experience of analysis work focusing on financial markets, and good knowledge of quantitative analysis.

As a person you are independent, prestigeless/flexible and enterprising. You also have good judgement and a good team player. You are a skilled analyst, are good at presenting and writing texts in both Swedish and English and have a keen interest in socioeconomic issues.

ABOUT THE DEPARTMENT: The Financial Stability Department works to ensure that the Riksbank is able to identify at an early stage any risks that might lead to the financial system becoming unstable and inefficient. We are also responsible for ensuring that the Riksbank can manage a financial crisis, if one should nevertheless arise. Some of our analyses and conclusions are presented twice a year in the Financial Stability Report, as well as in speeches made by Executive Board members, opinion articles in the press and consultation responses.

Much of our work is done in cooperation with other central banks, especially those within the European System of Central Banks (ESCB). We also take an active role in other international organisations whose remit includes financial stability, including the Basel Committee, the IMF and the Bank for International Settlements (BIS).
