Legal Institutions are crucial for financial development. Strong laws and their enforcements define and enforce private property rights, facilitate private contracts and provide checks and balances on the government, and therefore promote economic activities and finance. Empirical evidence suggests that legal institutions differ a great deal across countries. This finding raises some critical questions such as how do countries with weak laws or enforcements cope with this problem? More specifically, how do their firms operate without the legal protection of private property rights and contracts? Do they have other, alternative or informal mechanisms to support property rights and facilitate private contracting, assuming these are the preconditions to economic growth? Research on these areas will advance our understanding of the role of

legal institutions in shaping financial development and may ultimately yield valuable insights for policy makers and institutional reforms.
