There is an option that the participant can serve as a discussant of a paper of his/her own area of interest and certificate will be issued to such participant. You are also welcome to volunteer to participate as session chairs, reviewers and members of the program committee.

#### **Proceedings, Publication Opportunity, Best Paper Award and Feedings**
